A RESOLUTION CANCELLING THE APRIL 3, 2018 REGULAR TOWN ELECTION
AND DECLARING THE CANDIDATES TO BE ELECTED

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE,
COLORADO:

Section 1. The Town Council of the Town of Breckenridge finds, determines, and declares as follows:

A. The regular Town election of the Town of Breckenridge is scheduled to be held on April 3, 2018.

B. Section 1-12-10 of the Breckenridge Town Code provides as follows:

1-12-10: ELECTION MAY BE CANCELLED – WHEN: If the only matter before the voters is the election of persons to Town office and if, at the close of business on the sixty fourth (64th) day before the election, there are not more candidates than offices to be filled at such election, including write-in candidates filing affidavits of intent pursuant to Section 1-12-9 of this Chapter, the Town Clerk, if instructed by resolution of the Town Council either before or after such date, shall cancel the election and by resolution declare the candidates elected. Upon such declaration the candidates shall be deemed elected. Notice of cancellation shall be published by the Town Clerk, if possible, in order to inform the electors of the Town, and notice of such cancellation shall be posted at each polling place and in not less than one (1) other public place.

C. The only matter before the voters at the April 3, 2018 regular Town election is the election of persons to Town office.

D. At the close of business on January 29, 2018, such date being the sixty fourth (64th) day before the date of the regular Town election, there were not more candidates than offices to be filled at the regular Town election, including write-in candidates filing affidavits pursuant to Section 1-12-9 of the Breckenridge Town Code.

Section 2. Pursuant to the authority granted to the Town Council by Section 1-12-10 of the Breckenridge Town Code, the Town Clerk is instructed to cancel the regular Town election scheduled to be held on April 3, 2018.

Section 3. Upon the Town Clerk's cancellation of the regular Town election as required by Section 2 of this resolution, the following three (3) candidates for the office of member of the Town Council of the Town of Breckenridge, namely (in alphabetical order):

Gary Gallagher
Erin Gigliello
Elisabeth Lawrence

are declared to have been elected, each for a four (4) year term of office, at the regular Town election of April 3, 2018. Such election shall be deemed to be effective as of 12:01 A.M. on April 3, 2018.

Section 4. In order to inform the electors of the Town notice of cancellation of the April 3, 2018 regular Town Council election shall be published by the Town Clerk on the Town's website in accordance with Section 1-22-2(A) of the Breckenridge Town Code. In addition, notice of such cancellation shall be posted at each Town polling place and in not less than one (1) other public place.

Section 5. This resolution is effective upon adoption.
