A RESOLUTION IN SUPPORT OF SUMMIT COUNTY'S REFERRED MEASURE 1A

WHEREAS, the Board of County Commissioners of Summit County, Colorado have submitted a referred measure, denominated as Referred Measure 1A, to the registered electors of Summit County at the election to be held on November 8, 2018; and

WHEREAS, according to the information that has been provided to the Town Council, if passed by the electors:

- Measure 1A will provide a temporary 4.7 mill property tax levy throughout Summit County for a period of ten years starting January 1, 2019;
- The revenue raised by Measure 1A will generate up to \$8.8 million annually for wildfire preparedness, mental health and suicide prevention, recycling and waste diversion, affordable early childhood care and learning, and public building improvements; and
- The property tax levy authorized by Measure 1A will amount to \$2.83 per month in property taxes per \$100,000 of residential property value during the first fiscal year of the new levy (i.e., a property owner will pay \$169.80 per year for a \$500,000 home);

and

WHEREAS, Section 20, Article 10 of the Colorado Constitution requires voter approval for the imposition of any new property tax levy; and

WHEREAS, Section 29-1-301, C.R.S., requires voter approval for the imposition of an additional tax levy to the extent that such levy may exceed the otherwise authorized annual property tax increase of 5.5 percent for county purposes (of the amount of revenue levied in the prior year) contained therein; and

WHEREAS, the Town Council of the Town of Breckenridge supports the passage of Measure 1A.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO, as follows:

Section 1. The Town Council of the Town of Breckenridge supports the passage of Referred Measure 1A that will appear on the November 6, 2018 election ballot, and urges the electors of the Town to vote in favor of Referred Measure 1A.

Section 2. Adoption of this resolution may be reported or distributed only through established, customary means, other than paid advertising, by which information about other proceedings of the Town Council is regularly provided to the public.

Section 3. This resolution shall become effective upon its adoption.
